CATHOLIC CHARITIES OF ST. LOUIS (CCSTL) IS THE CENTRAL OFFICE OF THE CATHOLIC CHARITIES OF THE ARCHDIOCESE OF ST. LOUIS, SUPPORTING OUR FAMILY OF MINISTRIES. THE MINISTRIES EACH FOCUS ON DIFFERENT AREAS OF NEED (HOMELESSNESS, SUBSTANCE USE DISORDERS, DOMESTIC ABUSE, MENTAL HEALTH, SENIOR SERVICES, FOSTER CARE AND MORE). IN CALENDAR YEAR 2021, OVER 98,000 PEOPLE BENEFITED FROM THE FEDERATION'S SERVICES. 53.4% OF THESE PEOPLE LIVED BELOW THE POVERTY LINE.

CCSTL CENTRAL OFFICE PROVIDES THE MINISTRIES NECESSARY HUMAN RESOURCES, DEVELOPMENT, COMMUNICATIONS, TRAINING, QUALITY ASSURANCE, FINANCE, MISSION INTEGRATION, SERVICE INTEGRATION AND ADVOCACY SUPPORT, ALLOWING THE MINISTRIES TO FOCUS THEIR RESOURCES ON THEIR RESPECTIVE MISSIONS.
