CCSTL ALSO PROVIDES DIRECT AND INDIRECT FINANCIAL SUPPORT TO THE MINISTRIES, INCLUDING \$0.2 MILLION DIRECT FUNDS, \$0.7 MILLION "PASS-THROUGH" GRANTS AND \$2.6 MILLION IN-KIND CENTRALIZED SERVICES

IN JANUARY 2024, CCSTL WAS AWARDED A THREE-YEAR CATHOLIC CHARITIES USA DISASTER OPERATIONS REGIONAL CAPACITY INITIATIVE GRANT.
